

## Terms and conditions of the "Less Waste" Competition

1. These terms and conditions (hereinafter referred to as Terms) stipulate the rules and conditions of the "Less Waste" Competition in a hackathon event HackYeah and is an annex to the general terms and conditions of HackYeah Hackathon.
2. The Hackathon Sponsor and promising prize within the meaning of art. 921 § 3 of the Civil Code (Journal of Laws 2017, item 459) is Proidea Sp. Z O.O., with registered office in Kraków 30-418, ul. Zakopiańska 9, registered under numbers: NIP (Taxpayers ID no): 6793088842 and REGON (Business ID no): 122769022, entered into KRS (National Court Register) under number 0000448243, which may be reached at [biuro@proidea.org.pl](mailto:biuro@proidea.org.pl) email address.
3. Details of the task will be presented at the start of the competition.
4. Participation in the "Less Waste" Competition may be taken individually and in teams of up to six people who have started solving the competition task no earlier than 12:00 on November 19th and forwarded the task for evaluation no later than 12:00 on November 20th. The task submitted for evaluation must include: project title, team ID, project description, maximum 10-slides PDF presentation and could include: snapshots, code repository, demo links, graphic materials and other materials related to the project. The task solutions should be submitted to platform Challenge Rocket in English only.
5. Participants related or affined with members of the "Less Waste" Competition Jury and employees of promising the prize are excluded from participation.
6. The prize in the competition is 10 000 PLN (including tax).
7. The Competition is to present the solutions to the problem - an open task. The solutions of respective tasks will be evaluated in 2 phases:
  - a. phase 1 - by a Jury assigned to a respective task, consisting of Mentors (at least two members)
  - b. phase 2 - by the audience, i.e. other Participants of the event, in live voting.
8. The members of the jury will select a chairman from among themselves.
9. In the event of an equal number of votes, the Jury's vote shall decide in both phases.
10. Judging criteria are as follows:
  - a. Idea — 30%
  - b. Technical aspects — 30%
  - c. Design — 20%
  - d. Relation to category — 10%
  - e. WOW! Factor — 10%
11. In order to receive the award, the project must receive a minimum of 50% of the points in 1 step. Jury and Jury members' decisions are final and cannot be appealed.
12. Any alterations or revisions made after the statutory time is expired are illegal. Any alterations and modifications made after the statutory time is expired will not be considered by the Jury.
13. The author's proprietary copyrights to the awarded solution will not be transferred to the Competition Sponsor.
14. Jury members will be posted on the HackYeah website no later than November 19th.
