Terms and conditions of the Games for good! competition

- 1) These terms and conditions (hereinafter referred to as Terms) stipulate the rules and conditions of the "Games for good!" Competition in a hackathon event HackYeah and is an annex to the general terms and conditions of HackYeah Hackathon.
- 2) The Hackathon Partner and promising the prize within the meaning of art. 921 § 3 of the Civil Code (Journal of Laws 2017, item 459) is Bank Gospodarstwa Krajowego, with registered office in Warsaw al. Jerozolimskie 7, 00-955 Warsaw, registered under following numbers: NIP (Taxpayers ID no): 5250012372 and REGON (Business ID no): 000017319, which may be reached at bgk@bgk.pl e-mail address.
- 3) Details of the task will be presented at the start of the competition.
- 4) Participation in the "Games for good" Competition may be taken individually and in teams of up to six people who have started solving the competition task no earlier than 12:00 on November 19th and forwarded the task for evaluation no later than 12:00 on November 20th. The task submitted for evaluation must include: project title, team ID, project description, maximum 10-slides PDF presentation, project should include: snapshots, code repository, demo links, graphic materials and other materials related to the project. The task solutions should be submitted to platform Challenge Rocket in English or Polish.
- 5) Participants related or affined with members of the "Games for good!" Competition Jury and employees of promising the prize are excluded from participation.
- 6) The solutions of the tasks will be evaluated by a Jury assigned to the task, consisting of at least two members. The prize in the competition is 60 000 PLN (including tax) for the winner and shall be paid to a winner/winners within 60 days from the day of announcement of the winner of the Contest.
- 7) Jury and Jury members' decisions are final and can not be appealed.
- 8) Judging criteria are as follows:
 - Idea 30%
 - Technical aspects 30%
 - Design 20%
 - Relation to category 10%
 - WOW! Factor 10%
- 9) Any alterations or revisions made after the statutory time is expired are illegal. Any alterations and revisions made after the statutory time is expired will not be considered by the Jury.
- 10) At the time of paying out the prize as stipulated in Point 6 above, Bank Gospodarstwa Krajowego acquires the ownership rights to the idea that won the contest, including the copyrights to the idea on all fields of exploitation existing at the date of the transfer of copyrights, in particular on those fields stipulated in Article 50 of the Polish Copyright Act:

- a) in the field of recording and reproduction of the idea production of copies of the idea by a specific technique, including printing, reprographic, magnetic recording and digital techniques;
- b) in the scope of trading the original or copies on which the idea was recorded placing on the market, lending or renting the original or copies;
- c) in the scope of disseminating the idea in a way other than specified in point b public performance, exhibition, displaying, reproducing, broadcasting and rebroadcasting, as well as making the idea available to the public in such a way that everyone can have access to it in a place and time of their choice.

Bank Gospodarstwa Krajowego acquires also the rights to modify the idea or to develop it further. The prize on behalf of the Promisor will be paid by the Hackathon Organizer.

- 12) Participation in the competition means acceptance of all terms of the hereby Contest Rules.
- 13) The Partner may cancel the Contest without giving a reason.
